


The Opportunity

The West Suffolk Woodlands Warden is a key member of the West Area Reserves Team, working under the direction of the South West Suffolk Senior Warden to deliver high-quality conservation management across Bradfield Woods, Bulls Wood, Bonny Wood and Combs Wood, while supporting work on other West area reserves as required.

The post leads on turning the Trust's conservation objectives into practical action: producing and updating reserve management plans; planning and delivering habitat management works; coordinating ecological monitoring; maintaining machinery, equipment and site infrastructure; and overseeing contractors and compliance, including consents, budgets and reporting.

A major part of the role is recruiting, developing and leading volunteers to support conservation work across the reserves, ensuring excellent standards of health and safety at all times. The role also includes public engagement, helping to ensure a welcoming and accessible experience for every visitor. Friendly, organised and hands-on, the Warden is a visible ambassador for Suffolk Wildlife Trust, raising awareness of the Trust's work through day-to-day engagement, events and communications that support the mission to bring nature back.



Our Nature Reserves

Across Suffolk, the Trust cares for 50 reserves covering over 2,900 hectares (7,100 acres), protecting a wide range of habitats and providing opportunities for people to connect with nature. Visitors are encouraged to help protect these precious sites by sticking to paths, keeping dogs on leads and following on-site guidance.

In West Suffolk, the Trust looks after some outstanding woodland reserves, including Bradfield Woods, Bull's Wood, Bonny Wood and Combs Wood - a cluster of sites that showcase the richness of Suffolk's ancient woodlands, with habitats shaped by traditional management and careful monitoring.

These reserves offer everything from spring woodland wildflowers to botanically rich coppice and rides and they play an important role in restoring biodiversity across the wider landscape. West Suffolk is also home to the Trust's Lackford Lakes visitor centre near Bury St Edmunds & Bradfield Woods, helping welcome and inspire visitors while supporting the Trust's mission & strategic plans.

Suffolk Wildlife Trust is the county's nature charity, protecting and restoring Suffolk's wildlife.


Founded in 1961, we have led conservation efforts across Suffolk for more than 60 years, safeguarding some of the county's most important wildlife areas as nature reserves.

Our Mission: Brining Nature Back to Suffolk

Our Vision: A wilder Suffolk, where nature is thriving and abundant, because everyone is united in valuing nature and doing more to help.

As a grassroots organisation, we deliver our ambitious work by inspiring people & empowering communities to care for, and act for, nature. Alongside this, we manage 50+ nature reserves & two visitor centres (Carlton Marshes & Lackford Lakes) and we advocate for wildlife across the county.

In the decade to 2030, we are committed to scaling up our work across the county. Our aim is for 30% of Suffolk to be connected and well looked after for nature by 2030, so that species and habitats can recover and thrive, and for 1 in 4 people to be actively helping to achieve this.


Suffolk Wildlife Trust is an organisation that makes a difference.



We are a registered charity with a Board of Trustees, 1,300 volunteers & 28,000 members. We are part of The Wildlife Trusts – a UK federation of 46 local Wildlife Trusts through the UK that together has a powerful collective voice with over 850,000 members & caring for more than 2,300 nature reserves.



We employ around 100 staff across 15 departments, organised within three main directorates. Each directorate is led by a Director, and each department has an Operational Lead who provides leadership for a key area of activity.

Role Description

Every role has three key areas of focus known as the “Power of 3” to support our mission, vision & strategic goals. Typically, you should expect to spend 80% of your time on the following:

1. Work under the direction of the Senior Warden to ensure Suffolk Wildlife Trust reserves are managed in accordance with conservation objectives:

- Write Reserve Management Plans for all ‘home’ reserves for submission to the Senior Warden.
- Input into agri-environment scheme agreements in conjunction with the Senior Warden and Reserves Officer that help deliver desired management outcomes.
- Produce annual reports and other updates and reports as required for all ‘home’ reserves.
- Assist the Senior Warden with budget planning for all ‘home’ reserves across the West Suffolk Woodlands, supporting the Senior Warden to deliver an affordable and priority focussed budget.
- Plan and undertake the habitat management activities set out in the agreed reserves management plans and/or agri-environment/woodland management agreements.
- Ensure all necessary consents for management work are obtained in advance of work.
- Undertake the care and maintenance for all machinery, vehicles and equipment used across your area including servicing and MOT’s as required.



- Prepare tenders, specifications and other relevant contract documents for contractors across your area, ensuring suitable paperwork is in place, such as insurance. Supervise contractors as required to support reserve management.
- Undertake the care and maintenance of reserve infrastructure across the West Suffolk Woodlands range of reserves.
- Undertake and coordinate ecological monitoring to gather conservation evidence that will determine conservation objectives and management actions contained within the relevant management plans. Write reports that capture and demonstrate this evidence.
- Support the running and maintenance of the Bradfield Woods workshop.
- Ensure and support the high standards of welfare for Trust livestock on reserves are met.

2. Lead and manage the Trust's Volunteers and internships/apprenticeships in the West Suffolk Woodlands:

- Lead and manage reserve volunteers.
- Prioritise, plan, write and deliver work schedules for your home reserves in conjunction with the Senior Warden.
- Ensure Health & Safety policies and procedures are communicated and adhered to, including incident reporting, COSHH and HAVs by all staff and volunteers working across the West Suffolk Woodlands.
- Ensure all volunteers are aware of and abide by relevant SWT policies and codes of practice.
- In conjunction with other Wardens maintain oversight of training needs for all volunteers working in your area.



3. Develop the role of the reserves as ‘flagships’ for the Trust’s work:

- Work with partner organisations, landowners and colleagues to rebuild biodiversity and deliver the Trust’s Wilder Landscapes vision.
- Raise awareness of wildlife conservation and demonstrate habitat management by being an ambassador, through open days, guided walks and talks as required. Including regular submissions to SWT social media platforms, radio interviews and information to SWT’s magazine.
- Report issues and undertake management work to ensure reserve trails, information signs, interpretation and site infrastructure are safe, clean, on-brand and accessible.
- Contribute as required to funding applications and reporting requirements for grant funded projects on sites.

This is a permanent position working 37.5 hours per week (five out of seven days each week - standard hours are Monday to Friday from 9:00am to 5:00pm) based at Bradfield Wood Nature Reserve. The starting salary will be between £28,088.00 & £30,088.00 per annum depending on skills, knowledge and experience.

Employee Benefits

Annual leave entitlement starts at 33 days per annum (including Bank Holidays), increasing annually to 38 days, plus employees receive an additional day off for their birthday.
